- Six Board members were present; Joe Horton was absent.
- Approved April minutes. (Unanimous)
- Authorized a letter of support for the Jonesville VDOT Area Headquarters remaining in Jonesville. (Unanimous.)
- Directed County Administrator Hood to issue a letter of support for the Flanary Historical Site. (Unanimous)
- Authorized 100 percent of allowable fines for motor vehicle violations in Scott County to be directed to the Sheriff's Department to use for items as determined by the Sheriff that are currently covered by the annual budget. (Unanimous.)
- Authorized the purchase and installation of a winch on a County truck to be used
  in cleaning up illegal dumpsites, that the funds be taken from Board's
  Contingency, and that Litter Control Officer Jake Dougherty and Jon Lawson
  from Soil and Water Conservation District coordinate the clean-ups.

- Held public hearing on requirements and regulation of closure plans and demonstration of financial capability for Bellamy Manufacturing and Repair Company. Granted a waiver to Mr. Bellamy. (Unanimous)
- Authorized County Attorney Sally Little to advertise for public hearing on June 4, 2008 for consideration of closing a portion of Landfill Road. (Unanimous)
