Authorized a special use permit to Prime Tower Development LLC for the installation of a communication tower in the Nickelsville Area on tax map number 90-A-55 on Midnight Drive contingent that no lights are installed at the tower and electrical lines be installed underground if possible (unanimous)

Appropriated \$476.93 to Sheriff Drug Task Force Overtime Salaries (unanimous)

Directed that the subdivision ordinance be returned to the Planning commission with the direction that they include the County Attorney's recommendations in a revised draft and that a joint public hearing between the Board of Supervisors and Planning Commission should be advertised for March 10, 2014 at 6:00 p.m. (4 ayes and 3 nays)

Transferred funds for part-time help in emergency situations to 12540-3340 Information Systems – Contracted Maintenance (unanimous)

Tabled the Housing Authority Appointment until the March meeting and authorized that the position be readvertised (unanimous)

Tabled Refund on a paid erroneous assessment by BB&T Equipment Finance Corporation to obtain additional information from the Commissioner of the Revenue (unanimous)

Directed the Treasurer to issue a refund for a paid erroneous assessment of local taxes in the amount of \$243.87 to Great American Leasing (unanimous)

Authorized the County Attorney to advertise for public hearing to repeal the Enterprise Zone Ordinance (unanimous)

Approved Claims (unanimous)

Approved purchase of an enclosed trailer with rear ramp and side door in the amount of \$3,000 from Public Works Special Fund 7 and Husqvarna R322 T articulated rider mower in the amount of approximately \$5,000 from General Properties Fuel, Power Equipment – 43200-6008 and transfers \$500 from Manned Waste Sites Preemployment exams, \$3,500 from Collections Recycling, and \$500 from General Properties Travel (unanimous)

Authorized the County Administrator to send a letter of support for the Clinch River Initiative funding (unanimous)

Entered into closed session to discuss Real Estate being property in Gate City, Prospective Industry being a confidential Prospect for Weber City, and Contracts being a proposed contract with Scott County Telephone for phone service at the Community Services Building (unanimous)
