Any proposals received after this date and time will not be considered. All bids must be signed by an official agent or representative of the company submitting the bid.

Candidates must hold a Virginia Class A, B, or C (as appropriate for amount of your bid) Contractor’s license, and include the Virginia License Number with your bid.

Contract terms and conditions will be negotiated upon selection of the winning bidder. All contractual terms and conditions will be subject to review by Scott County Attorney and will include budget, schedule, and other necessary items pertaining to the project.

Any bidder must submit the **PROOF OF AUTHORITY TO CONDUCT BUSINESS IN VIRGINIA FORM**, which is attached to this Invitation to Bid with their bid or proposal.

Contract document will contain provisions prohibiting discrimination, prohibiting employment of illegal alien workers, and requiring a drug free workplace so as to comply with the foregoing legislation and will be subject to approval by the County Attorney as to legal form.
