Sealed Bids for Rebuilding of South Wall of Gymnasium, Weber City Elementary School, 322 Jennings Street, Weber City, VA 24290 will be received until 3:00 p.m., EST, Thursday, October 11, 2018, by Beeson, Lusk & Street, Architects at the Office of Scott County Public School Board, 340 East Jackson Street, Gate City, VA 24251 at which time they will be Publicly opened and read. Late Bids will be returned unopened. A Pre-Bid Conference is scheduled for Wednesday, October 3, 2018 at 3:30 p.m. EST at Weber City Elementary.

Scope of work shall include, but not limited to, removal of portions of the existing south wall of the existing gymnasium, replacement of removed portions and repairs to the existing structure.

All bidders must be licensed Contractors in the State of VA. The Bidder's license must be placed on the envelope containing the Contractor's bid, otherwise the bid will not be considered. The envelope must be sealed. Bids shall be received in accordance with Commonwealth of VA.
