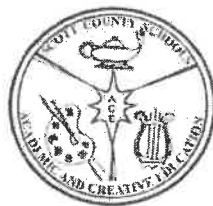

Sealed bids were not obtained for purchase requisition #10618 to Don Franklin Ford Lincoln, LLC for the purchase of (3) three 2020 Ford Transit Connect XL Vans for the Scott County Public Schools Bus Garage in the amount \$74,985. Of the four vendors that we received bids from, Don Franklin Ford Lincoln was the only vendor that had the three vehicles on site ready to purchase. Fairway Ford, Friendship Ford and Ken Wilson Ford would not have the vehicles in stock until February, 2021. One quote was obtained from another vendor but the vehicle was sold due to our time constraints of obtaining bids These vehicles are being purchased with Federal Coronavirus Relief Funds awarded to school divisions for expenses that were incurred beginning March 1, 2020 and ending on December 30, 2020. (ref. Superintendent's Memo #273-20) All funds must be expended by December 30, 2020.
