

PUBLIC NOTICE
BOARD OF EQUALIZATION FOR SCOTT COUNTY

Pursuant to Section 58.1-3331(E) of the Code of Virginia, public notice is hereby given that the Board of Equalization (BOE) for Scott County will meet on the days hereafter listed for the purpose of hearing complaints of inequalities including errors in acreage. Upon hearing such complaints, either oral or written, the BOE will give consideration **AND INCREASE, DECREASE OR AFFIRM** such real estate assessments. Before a change can be granted, the taxpayer or his agent must overcome a clear presumption in favor of the assessment. The taxpayer or agent must prove by producing substantial evidence that the property is not uniform with other similar properties or prove that the property is assessed in excess of its fair market value.

To appear before the BOE, please call (276) 452-0053 or (276) 452-0054 beginning Tuesday, June 21, 2022, from 9:00 a.m. - Noon and 1:00 p.m. - 5:00 p.m., Monday - Friday to schedule an appointment. Deadline for making appointments and for receipt of written complaints is Friday, July 8, 2022. Phone lines will not be operational on Monday, July 4, 2022. You may also write the BOE stating the complaint and email to: taxes@scottcountyva.com. Whether you telephone or write for an appointment, please provide the Tax Map Number of the parcel or parcels you wish to discuss. The Tax Map Number will be on your tax ticket or notice of assessment. Meetings of the BOE to hear objections will be held at the Scott County Park, which is off State Route 660, approximately 0.4 miles off Route 72 north of Gate City, Virginia.
