Scott County Schools Maintenance Department request an approval for the purchase of 500 tons of coal for the 2022-2023 heating season from Rick Begley Coal and Construction. Rick Begley provides the coal hauling services to each school that requires coal for the coal fired boilers under a 5 year contract which is good until June 30, 2023. Along with the coal hauling Rick Begley also assist Scott County Schools with the purchase of coal for the schools. An attempt of purchasing the coal was made with G & D Processing and 4th Generation Fuels with no reply. Red River Coal Company was a long-time provider of coal for Scott County Schools but cannot guarantee coal for the 2022-2023 heating season. Rick Begley has Houser Trucking that will provide 500 tons of coal for the school with the required specifications for the 2022-2023 heating season at \$265.00 per ton.
